

# SRTS 2024 Frequently Asked Questions

## What should I bring to the In-Person Symposium?

Be sure to bring your **ATRA username, password** that you registered with **and a mobile device** to view all conference information. You may use your mobile device throughout the conference for session verification, view the program, complete evaluations, and view the status of your CEUs. You may wish to print a copy of the program, as the program is only offered in digital format.

## What's new this year!!

New this year for our In-Person Symposium will be the **Zen Den**, a safe, quiet space for symposium attendees to take a breather, relax, refocus, or recharge without interruption. The Zen Den is provided by James City County, Norfolk, and Virginia Beach, Virginia Community Therapeutic Recreation Programs.

## What should I wear at the symposium?

SRTS recommends business casual attire. Please bring a sweater or light jacket as some of the rooms may get chilly. Unfortunately, SRTS has no control over the thermostat.

## What is the parking situation?

Parking at the hotel is free if you made your reservation under the SRTS room block.

## Are any meals included in the registration?

Lunch is provided as part of the general session on Thursday. Additionally, refreshments will be provided during breaks.

## Are there any socials planned?

Unfortunately this year we are not able to provide a social. We encourage you to network with other professionals during break times and in the evenings.

## Are masks required?

No, masks are not required, but feel free to wear one if you prefer.

## **I registered for the In-Person Symposium, do I need to pay extra for the On-Demand Sessions?**

Yes, you do. The on-demand portion of the symposium is a separate registration.

## **Will any In-Person Sessions be recorded and offered in the on-demand sessions?**

Some of the in-person sessions have been pre-recorded and will be offered as part of the on-demand symposium. In-person sessions will not be recorded on-site. These sessions are noted in the program.

## **Are the sessions pre-approved for CEUs?**

Yes, all sessions have been pre-approved by ATRA and NCTRC for CEUs.

## **How many CEU's can I earn during the symposium?**

- Attendees participating in the In-Person Sessions can earn up to 1.5 CEUs.
- Attendees participating in the On-Demand sessions can earn up to 0.7 CEU's.

## **Will I be able to check on the status of my CEUs throughout the symposium?**

Yes, the conference platform makes it easy to track CEUs as you earn them. You will need your **ATRA username** and **password** to view all conference information. You may use your mobile device throughout the conference for session verification, view the program, complete evaluations, and view the status of your CEUs.

## **When will I receive my CEUs?**

Whether you are attending In-Person or viewing On-Demand sessions, CEU credits for each course will be available upon successfully completing the session evaluation(s).

## **Are any of the On-Demand sessions going to be presented live?**

Yes, several of the sessions are being presented both in-person and on-demand. They are noted in the program.

## **How long do I have to watch the On-Demand Sessions?**

You will have four (4) weeks to complete the on-demand portion of the symposium, April 8 - May 3, 2024.
